### **Junior Development Scheme**

#### 1. Application form to be used

A copy of application form is attached.

#### 2. Enrolment requirements

Applicants should:

- (a) be resident in Hong Kong;
- (b) be at least 14 years old subject to a maximum age of 28;
- (c) excel in golf and have a handicap of less than 10;
- (d) be recommended by the Hong Kong Golf Association and participating as an Elite Squad member; and
- (e) not be a member of any golf club in Hong Kong.

#### 3. Maximum number of Junior Development Scheme Participants to be enrolled at any one time

No restriction.

#### 4. Playing and Access Rights

Participants will be entitled to:

- reserve starting times on weekdays except public holidays.
- play unaccompanied on the Course after 9am at any time throughout the year.
- use all F&B facilities except for the Lounge and Bar (where admittance is restricted to 16 or over) before or after playing golf.
- use the gym for 5 hours per week on Mondays from 7am to 12noon and accompanied with trainer.
   Participants are not allowed to:
- introduce other visitors.
- sign the F&B chits and they must use debit cards as and when required for payment of all services.

## 5. Amount of entrance and monthly fee payable

Scheme Entrance Fee: Nil. Monthly fee: HK\$180.

#### 6. Application procedures

- (a) Applicants should submit the completed application form together with a copy of his/her HKID card, Birth Certificate, two (2) passport size photographs, documentary proof of current handicap index, performance records, awards and personal Golf insurance, if applicable;
- (b) Applicants will be invited to interview by the Director of Golf and may be required to undergo such tests as regards playing ability and/or knowledge of rules/ etiquette as the Director of Golf may determine, and in addition, produce a recommendation from HKGA.

### 7. General rules applicable to Junior Development Scheme Participants

- (a) All Participants must abide by the Club's rules and regulations as determined by the General Committee from time to time, including the Club's Bye-laws and Junior Rules as applicable.
- (b) General Committee may in its absolute discretion terminate any individual Participant's continued participation in the Junior Development Scheme should the Participant cease to engage at the same level in golf that was undertaken at the time he or she joined the Scheme, without reason sufficient to satisfy the General Committee, or if the Participant is in breach of any of the Club's rules and regulations from time to time, or for any other reasonable grounds which the General Committee may see fit in its absolute discretion.
- (c) General Committee reserves the right from time to time to amend the terms of the Junior Development Scheme, as set out in this Annex (IV), in such manner as the General Committee may see fit in its absolute discretion.
